

## RENEWAL AGREEMENT

This Agreement ("Agreement") is effective January 1, 2023 ("Effective Date") by and between Kelly Services, Inc, with its principal offices located at 999 Big Beaver Road, Troy Michigan 48084 ("Kelly"), and Black Horse Pike Regional School District located at 508 Erial Road, Blackwood NJ 08012

Whereas Customer and Kelly entered into and Agreement for the 2021/2022 School Year (Prior Agreement) whereby Customer is to provide substitute staffing services to fill positions and the request of the customer;and

Whereas Customer and Kelly are desirous of entering into an Agreement for the 2022-2023 school year under substantially the same terms; amending the Prior Agreement with the provisions set forth below.

Now, therefore, be it agreed between the parties, as follows:

1. All terms and conditions of the Prior Agreement are incorporated herein with the following modifications:

a) Section 7 is modified to reflect that the term of this Agreement shall continue in effect until canceled by either party in accordance with the terms of the Prior Agreement.

c) The Detailed Per Diem Pricing Plan, attached as Addendum B to the Prior Agreement, shall be replaced with the following Pricing Plan Addendum C below:
