#### **Scope of Services:**

The Black Horse Pike Regional Board of Education desires to appoint a firm to provide architectural services to the Board. Applicants should demonstrate knowledge and experience with respect to all aspects of architectural services required by a school board. Any experience or knowledge of matters that directly affect the Board of Education should be addressed.

#### **Mandatory Minimum Qualifications:**

- 1. Must be certified to provide architectural services in the State of New Jersey.
- 2. Must have a minimum of ten (10) years' experience in providing architectural services to boards of education.
- 3. Must be experienced in obtaining permits and approvals from various state, county and local regulatory agencies.
