Scope of Services:

The Black Horse Pike Regional Board of Education desires to appoint a School District Solicitor who will be the chief, general legal officer of the Board. Applicants should demonstrate knowledge of general New Jersey School Law, New Jersey Special Education Law, and New Jersey Governmental Contracts Law. Any experience or knowledge of matters directly affecting the Board of Education should be addressed.

Mandatory Minimum Qualifications:

- 1. The firm must be licensed to practice law in the State of New Jersey for a period of not less than ten (10) years preceding the proposed appointment, and eligible to appear before all state and federal courts in New Jersey, as well as New Jersey administrative agencies and the Office of Administrative Law.
- 2. The firm shall have at least ten (10) years' experience in representation of School Districts and Boards of Education in any capacity.
- 3. The firm shall designate one professional within the firm who will be assigned to represent the interest of the School District. This individual shall have been admitted and/or licensed in his/her profession and be in good standing.
- 4. The firm and individuals assigned to work with the School District shall be well versed in all aspects of the School District's operations.
- 5. The firm must list past and present school districts or government authorities represented and in what capacity.
- 6. The firm must maintain a bona fide principal office in the State of New Jersey.
- 7. The firm must have sufficient support staff available to provide all general legal services required by the Board of Education including, but not limited to, legal research, preparation of resolutions, preparation of contracts and other legal documents.

All statements of proposals for professional service contracts shall include at a minimum the following information.

- 1. Names of individuals who will perform required tasks as well as the listing of their licenses.
 - A. Identify the person who will be primarily responsible for the services required by the Board of Education and provide a description of the experience of the primary person with projects and issues similar to those more specifically set forth in this RFP's and on behalf of the Board of Education of the Black Horse Pike Regional School District.
 - B. Identify persons who will serve as back up to the primary person including resumes of all parties.
- 2. Describe ability to provide services in a timely fashion including a description of your staffing and a description of your familiarity with the services required by the Board of Education of the Black Horse Pike Regional School District.

Evaluation of Proposals:

The School District intends to award a professional services contract for the defined scope of work under the Fair and Open Process in accordance with N.J.S.A. 19:44A-20.4 et seq.

The proposals will be evaluated by a committee of School District staff based upon information supplied by each Proposer in response to this RFP and the following criteria:

- · Ability to meet all minimum qualifications.
- · Overall knowledge and familiarity with the operations of the School District.
- Experience of the firm in providing similar services to other public bodies, with special emphasis on experience in New Jersey.
- · Qualifications and experience of the professional.
- Qualifications and experience of the other members of the professional's firm.
- The hourly rates proposed. The proposal shall identify whether clerical and other overhead costs will be billed separately or included in the hourly labor rate for the professionals.
