COMMITTEE MEETING MINUTES

- Policy/Bylaw 0134-Board Self-Evaluation was discussed and reviewed. Proposed changes indicated that NJQSAC no longer requires Board of Educations to complete a Board self-evaluation. All committee members agreed that it would be best practice for this Board of Education to continue to conduct the self-evaluation process, so long as the instrumentation provided by the New Jersey School Boards Association (NJSBA) continued to exist. Mr. Cappuccio contacted the NJSBA which indicated that the self-evaluation tool would continue to be offered.
