Upon completion of any Inspections a comprehensive report of the systems conditions will be prepared and forwarded directly to the Owner and Local Fire Official. Should any of your systems be deficient, a follow-up proposal will be sent to address the repairs necessary to bring your system back into compliance.

As a good faith effort to earn/retain your business, we have included a discount below where applicable.

DRY PIPE SPRINKLER SYSTEMS

Perform (1) annual inspections in accordance with NFPA-25, State of New Jersey & Local Codes and standard Insurance requirements. Perform a simulated trip test during each annual inspection with a full flow trip test every three years followed by draining of all low points. Reset interior of dry pipe valve, check pressure settings and operation of air compressor unit, drain low point drains. Conduct system main drain test, weather permitting. Check water flow detectors, tamper switches, alarm switches and audible alarm devices. Visually inspect all external components of system including control valves, drain valves, sprinkler heads and piping. Check and lubricate all fire department connections. Perform minor adjustments, as necessary.

NOTE - It is the Owner's responsibility to periodically drain all low point drains to avoid potential damage caused by freezing conditions. Due to several factors (such as the system tripping after our monthly maintenance) Allied Fire & Safety Equipment Co., Inc. cannot be held liable for freezing conditions even after this work is performed. Allied Fire & Safety Equipment Co., Inc. will not be held responsible for any damage as a result of freezing conditions due to improperly pitched pipe and/or lack of periodical draining.

Service requests made as a result of normal equipment fallure, customer abuse, fires, natural disasters, faulty wiring or electric problems will be charged at scheduled rates.

Allied Fire & Safety Equipment Co., inc. will make every attempt perform your regularly scheduled (quarterly, semi-annual or annual) inspections anytime during the month of their expiration but will not except liability for missing the

Allied Fire & Safety Equipment Co., Inc. will strive to do our best to avoid damage to other areas while performing our work but will not be held responsible for ceiling removal and/or replacement, painting and/or patching, carpet, equipment or furniture protection, staining/damage to sidewalks, driveways, lawns, landscape beds, etc..

If the use of a subcontractor is required due to proprietary systems or components, Allied Fire & Safety Equip, Co., Inc. will charge at the subcontractor's rate plus 30%.

Co., Inc. reserves the right to implement a reasonable temporary surcharge to adjust for any rise in pricing structures for fuel and/or material that may be caused by natural disasters, supply shortages or any other means not directly in control of Allied Fire & Safety Equip. Co., inc.

HAZARDOUS MATERIAL / ASBESTOS - If reasonable precautions will be inadequate to prevent foreseeable bodily injury or death to persons resulting from a material or substance, including but not limited to asbestos or polychlorinated biphenyl (PCB), encountered on the site, Allied Fire & Safety Equip. Co., Inc., shall upon recognizing the condition, immediately stop work in the affected area and report the condition to the Customer in writing.

The Customer shall obtain the services of a licensed laboratory to verify the presence or absence of the material or substance reported by Allied Fire & Safety Equip. Co., Inc. and, in the event such material or substance is found to be present, to verify that it has been rendered harmless. The Customer shall supply in writing, the names of the persons or agencies that have performed the testing or are to perform the task of removal or safe containment of the material or substance. Allied Fire & Safety Equip. Co., Inc. shall notify the Customer in writing of any objection to the proposed person or entity. When the material or substance has been rendered harmless, work in the affected area shall resume upon written agreement of the Customer and Allied Fire & Safety Equip. Co., Inc.

To the fullest extent permitted by law, the Customer shall indemnify and hold harmless Allied Fire & Safety Equip. Co., Inc. for all cost and expense thereby incurred.

PAYMENT TERMS - Invoicing is generated upon performance of a specific inspection or item in this Agreement. Payment is strictly due thirty (30) days from date of our invoice unless special arrangements are made. You may opt to pay by check, cash, Master Card, Visa or AFT/ACH/EFT. Now customers are required to complete a credit application or will be required to pay COD. Customer will be required to submit such financial information as Allied Fire & Safety Equip. Co., Inc. may reasonably require for determination of credit terms.

If Allied Fire & Safety Equip. Co., Inc. has not granted credit to customer, payment terms are cash on delivery. There will be a \$50.00 cancellation charge if customer does not have required COD at the time of service and must reschedule. All COD orders totaling \$1000 or more must be paid with certified funds (certified check, money order or cashier's check). There will be a \$35.00 service charge on all returned checks.
