

AMENDMENT #1 TO CB-00019795

COLLEGE READINESS AND SUCCESS CONTRACT

THIS AMENDMENT #1 ("Amendment"), amends that certain College Readiness And Success Contract dated *May 31*st, 2017 filed under College Board Contract Number CB-00019795 (the "College Readiness And Success Contract"), by and between the College Board ("College Board") and Black Horse Pike Regional School District ("Client"). Capitalized terms used herein shall have the meaning ascribed in the College Readiness And Success Contract.

WHEREAS, Client and College Board entered into the College Readiness And Success Contract to implement the SAT National Bulk with Essay Programs for the 2017-2018 school year; and

WHEREAS, Client has provided updated information that modifies certain provisions in the College Readiness And Success Contract; and

WHEREAS, the parties desire to enter into this Amendment to reflect the updated information from Client to include the SAT National Bulk without Essay for 11th grade to their contract

NOW, THEREFORE, in consideration of the mutual promises, representations and covenants set forth herein, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:
