2020-2021 Orthopedic/Sports Medicine Services Contract

Reconstructive Orthopedics and Black Horse Pike Regional School District are entering into the below outlined service contract as the exclusive Orthopedic and Sports Medicine provider for the Black Horse Pike Regional School district for a one-year term from August 1, 2020 through July 31, 2021. Below you will find the scope of services that Reconstructive Orthopedics can provide to the Black Horse Pike Regional School District which includes Triton, Highland and Timber Creek High Schools.

Reconstructive Orthopedics:

The following coverage, services and support will be provided to the BHPRSD by Reconstructive Orthopedics physicians and staff for the term of this agreement. Services are subject to change. Reconstructive Orthopedics will provide thirty (30) days' notice for any services that are discontinued during that time this agreement is in effect.

- Reconstructive Orthopedics will become the exclusive orthopedic & sports medicine provider to the BHPRSD. The current Primary Care Physician(s) would remain in place and act as the School District Physician which would include providing physicals and primary game coverage. Reconstructive Orthopedics will provide game coverage in the event that there are two football games being played at the same time resulting in the need for additional coverage or in the event that coverage is requested in advance and Reconstructive Orthopedics has availability for requested coverage needs. Coverage will not be provided for away games unless specifically requested and agreed to in advance. Additional coverage and away coverage is subject to compensation to be mutually agreed upon.
- Concierge services provided to players, coaches and athletic training staff to include
 - ATC Assist: This service is provided to athletic trainers and coaches that require the ability to connect with clinical staff 24/7. Clinical staff can be contacted via email at ATCAssist@reconstructiveortho.com 24/7 for assistance.
 - MVP Athlete Access: Athletes, parents, and coaches will be provided access to expedited care and dedicated service through MVP Athlete Access by calling **(856) 641-0770**

- Services:
 - Evaluation & Treatment of all musculoskeletal injuries by board certified & fellowship trained orthopedic & sports medicine specialists.
 - Onsite X-ray
 - Concussion Management including ImPACT testing
 - Casting, Splinting, Bracing and Crutches
 - Customized education (upon request) for patients, players, parents, coaches, and athletic trainers

- Reconstructive Orthopedics will provide \$2,000.00 annually to each of the following high school's Athletic Departments: Triton, Highland and Timber Creek. Payments will be made in three (3) installments at the beginning of each of the fall, winter and spring sport's seasons in the amount of \$666.67. In the event that any season is shortened or delayed, a pro-rated installment will be made based on the number weeks completed. Monies are to be used at the discretion of the Athletic Trainer for supplies, equipment, educational studies, or another use directly related to activities that will support and enhance the athletic training services provided by the athletic trainer.
- Reconstructive Orthopedics shall provide proof of appropriate general liability insurance coverage naming the BHPRSD as an additional insured. In addition, Reconstructive Orthopedics agrees to indemnify and otherwise hold the BHPRSD harmless for any acts of negligence relative to their employees providing services under the terms of the herein agreement. Said indemnification is intended to cover both BHPRSD employees, officers as well as any third-party participants in the BHPRSD sports programs.

Black Horse Pike Regional School Districts

- Will grant Reconstructive Orthopedics the ability to promote via social media, company website, or print (flyer, magazine, newspaper, etc.) that the BHPRSD, Triton, Highland and/or Timber Creek has partnered with Reconstructive Orthopedics for orthopedic & sports medicine services.
- Will grant Reconstructive Orthopedics exclusive orthopedic & sports medicine advertising rights on athletic fields and within gymnasiums by way of banners,

signage, or equivalent to be mutually agreed upon at each school consisting of Triton, Highland & Timber Creek.

- Will grant access to or assist in the distribution of materials provided by Reconstructive Orthopedics to promote programs, services, events or announcements within the school district at least twice per quarter.
- Will communicate with parents, student-athletes, coaches and administration the partnership with Reconstructive Orthopedics and the services available through our partnership.
