## GLOUCESTER COUNTY VOCATIONAL-TECHNICAL SCHOOL DISTRICT TUITION CONTRACT AGREEMENT

GCVTSD Tuition 20/21 sy

AGREEMENT dated this September 2, 2020, between the **BLACK HORSE PIKE REGIONAL Board of Education**, in the State of New Jersey (hereinafter referred to as the "SENDING DISTRICT"), and the **Board of Education of the Special Services School District and the Vocational School District of the County of Gloucester** and the State of New Jersey (hereinafter referred to as the "RECEIVING DISTRICT").

## **WITNESSETH**

NOW, THEREFORE, in consideration of the covenants herein contained, the parties agree as follows:

- The SENDING DISTRICT agrees to purchase educational services from the RECEIVING DISTRICT. The RECEIVING DISTRICT
  agrees to provide educational services to the SENDING DISTRICT in accordance with the applicable New Jersey Statutes and the
  rules and regulations of the State Board of Education. The specific educational services to be purchased and provided are described
  in 1a. below.
- 1a. The specific educational services described in this section or attached as an appendix to this AGREEMENT are to be provided for the resident pupils in grades 9 through 12 from the SENDING DISTRICT.

## Career – Technical Programs

- 2. This AGREEMENT shall be in effect for the 2020–2021 school year. The educational services shall commence on September 2, 2020 and terminate no later than June 30, 2021.
- 3. Tuition charges, as part of this AGREEMENT, as well as the payment of same shall be made in accordance with the applicable New Jersey Statutes and the rules and regulations of the State Board of Education.
- 4. The SENDING DISTRICT agrees to pay the tentative tuition charge of \$2,502.00 billed at \$250.20 monthly for ten months less any prior year credits to the RECEIVING DISTRICT commencing no later than September 2, 2020 and continuing through June. The payments shall be due on the first of each month. If applicable, the SENDING DISTRICT agrees to pay directly an annual non-resident fee of \$5,364.00 to the RECEIVING DISTRICT calculated in accordance with N.J.S.A.18A:54-20.1 and billed at \$536.40 monthly.
- 4a. In the event that it is later determined that the tentative tuition charge was greater than the "actual cost per pupil" as certified by the commissioner multiplied by the actual average daily enrollment received, the RECEIVING DISTRICT will return the excess amount to the SENDING DISTRICT no later than the end of the first school year following this contract year. The RECEIVING DISTRICT has the option to pay such excess amount or to credit such excess amount to the SENDING DISTRICT in accordance with the following payment schedule:

June 30, 2021 - 100%

4b. In the event that it is later determined that the tentative tuition charge was less than the "actual cost per pupil" as certified by the commissioner multiplied by the actual average daily enrollment received, the RECEIVING DISTRICT will charge the SENDING DISTRICT no later than the end of the third school year following the contract year the amount owed as follows:
