

MUNICIPAL
SHARED SERVICES AGREEMENT

THIS AGREEMENT, dated 14th day of December, 2017 by and between TOWNSHIP OF GLOUCESTER, a municipal corporation of the State of New Jersey, located at Chews Landing Road, P.O. Box 8, Blackwood, New Jersey 08012 (hereinafter called "GLOUCESTER TOWNSHIP"), and the BLACK HORSE PIKE REGIONAL BOARD OF EDUCATION, located at 580 Erial Road, Blackwood, NJ 08012 (hereinafter called "Regional Board of Education").

WITNESSETH

WHEREAS. The parties desire to enter into a Municipal Services Agreement authorizing Gloucester Township to provide "Brine Solution" and to included "Salt" and "Asphalt Repair Services" to Regional street / parking lots and

WHEREAS. The parties desire to enter into an agreement amending the previous shared service agreement between GLOUCESTER TOWNSHIP and REGIONAL BOARD OF EDUCATION for "Brine Solution" and to include "Salt" and "Asphalt Repair Services" to Regional streets / parking lots.

WHEREAS. The parties desire to enter into an agreement amending the previous shared service agreement between GLOUCESTER TOWNSHIP and REGIONAL BOARD OF EDUCATION for "Asphalt Repair Services" to Regional streets / parking lots.

NOW THEREFORE, for and inconsideration of the signing of this Amending Agreement by the parties, and in further consideration of the terms and covenants of the within Agreement, and the mutual benefits derived by the Parties hereto, the Parties do hereby agree as follows:

ARTICLE I
AGREEMENT

A. Gloucester Township will provide "Brine Solution" and "Salt" to the Regional Board of Education. The "Brine Solution" and "Salt" will be provided on cost Schedule "A" and by pick-up at the Gloucester Township Public Works Building during the term of this agreement. The pick-up dates shall be scheduled by the respective municipal and Board of Education department director.

B. Gloucester Township will provide "Asphalt Repair Services" to the Regional Board of Education. The asphalt repair services will be provided on an as needed basis with the pot hole repair machine being assigned, during the term of this agreement. The dates shall be scheduled by the respective municipal and Board of Education department director.

C. Regional Board of Education shall pay compensation to Gloucester Township at cost for "Brine Solution", "Salt" and "Asphalt Repair Services" to be paid within 45 days following the Regional School Board's receipt of a purchase voucher from Gloucester Township.

D. All other Terms and Conditions contained in the original Shared Services Agreement for “Brine Solution”, “Salt” and “Asphalt Repair Services” shall continue and remain in full force and effect and remain unchanged by this Amending Agreement.

IN WITNESS WHEREOF. The parties have caused this agreement to be duly executed and delivered by their Respective officers thereunto duly authorized and have caused their respective seals to be hereunto affixed and duly attested all as to the date first above written.

SCHEDULE "A"

1. The Black Horse Pike Regional Board of Education shall schedule all brine solution pick up Through the Gloucester Township Department of Public Works.
2. Brine Solution will be billed at the current rate and availability of brine solution per gallon which will include a 15% Township administration charge.
3. Asphalt Repair Services will be billed at the current rate cost.
4. The prices are \$ 85.32 / ton for salt (treated); \$.25 / gallon for brine. Prices may go up in the future due to supply and demand.
