Student reached said distributor convinced him to meet in a parking lot in order to get cell phone back. At parking lot, scuffle, police summoned, GT police arrested students. 4 current TC students remanded to CC jail or juvenile prison.

12/11/13 – TC notified first day of suspension. Home instruction services to begin once removed from prison.

1/6/14 - students with special needs met with Administration. TC officials recommended 45 days removal. Concerns regarding conduct outside of school that may lead to destruction of materials outside and inside school and safety and security of students/staff.

Students and parents met with Mr. Cappuccio and TC Administration - recommendation to serve in Alternative High school in District.

appealed the 45 day suspension of her son. She was given the opportunity to ask questions regarding the incident. Dr. Repici explained to her the decision made by Timber Creek Administrators.

The Board will deliberate on this matter.
