There are a host of school and COVID related updates

This week marks the second half of the 3rd marking period, so students should be aware of their personal goals and be able to determine if their grades in the first and second marking periods are aligned to those goals. If not, there is still time to put the work in to improve upon those performance outcomes; there is a need to focus on the end of the third marking period...now.

Spring is symbolically linked to renewal. A time of year in the natural world where there is an awakening. Tree buds blossom, creatures prepare for a summer bounty, and New Jerseyans are ready for warmer weather. Warmer weather marks the beginning of the 4th marking period and a whole host of Spring school events, like the beginning of Fine Arts Performances, Volleyball, Wrestling, and other Spring Sports. We look forward to seeing our students' talents shared with our staff, their peers, and the community over the next few months.

New Jersey continues to have COVID related limitations that will influence Spring school events. For instance, <u>Executive Order No. 157</u> limits school social functions, like dances. We are still forced to follow social distancing and capacity limitations imposed by the Department of Health for indoor and outdoor events. We will do everything we can to permit caregivers to observe students' events and ceremonies in person. When not possible, students' performances, events, and celebrations will be observable through a virtual and remote format.

Over 1,050 respondents answered our parent survey. As a result, 60% of respondents indicated that their children are participating in the hybrid learning model and would continue to do so if we increased the number of school days a week students attended. About 80% of those respondents asked to increase the number of half or full days a week students attend. As a result, we are investigating ways to address those survey results.

Even with 48% of our students learning remotely every day, we still have to design in-person learning in a way that mitigates COVID-19 transmission. We still have students and their loved ones who are not vaccinated. We still have educators and support staff personnel who are not vaccinated. The Department of Health, the Department of Education, our own school physician and nurses, and the American Academy of Pediatrics recommend six feet of social distancing in secondary schools. In order to increase the number of days students attend school a week, we will deploy additional air purification systems, increase fresh air intake when necessary, purchase additional desk barriers, and work with our transportation vendors to transport students within the bus capacity limitations.

There is no evidence that we are aware of linking COVID-19 transmission between student to adult or between adult to student within our schools. This may be due to our mitigation efforts thus far. Nationally, there are still approximately 65,000 positive COVID-19 cases per day. Regionally, our percent positivity rate is where it was in July, so there is still a risk of contracting COVID-19 within our local communities. It is our hope to get as many of our staff members and community members vaccinated in the coming months, so that we can work towards a greater sense of normalcy. We appreciate your efforts to follow all of the safety guidelines...we are so close to getting back to normal operations.... with your help, we will get there safely.

Thank you.

Please utilize the services that are still available to students, even though we are operating a hybrid learning model. Our school counselors are ready to assist students and parents with college and career planning and providing students with strategies to improve their outlook. We have reading specialists, language arts literacy tutors, math tutors, and over 300 eager teachers to assist students with academic support. As caregivers, please remember to check your child's grades by logging into the Genesis Parent Portal. Please direct any questions to your child's teachers and they will respond in a timely fashion.

Travel Advisory

It has come to our attention that some families or individuals have travel plans over the upcoming Spring Break. While we recognize the need to "take a break", we discourage travel outside of the approved states of NY, PA, CT, and DE. Some travel may be unavoidable, however, in the interests of everyone's safety and in accordance with New Jersey Travel Advisories, please adhere to the guidelines outlined by the New Jersey Department of Health, as doing otherwise can impact the safety of other students and staff members. 3-5 days upon returning from traveling, travelers should consider getting a viral test. Travelers and residents returning from any US state or territory beyond the immediate regional (NY, PA, CT, or DE) should quarantine at their home or lodging for a full 7 days. If the test is positive or no test was available, then travelers would have to quarantine for at least ten (10) days after travel. See the links below for all of the details. Career Corner

Since the Counseling Offices are in the midst of scheduling our students for next school year, I wanted to highlight one of our newer Career Exploration Programs (CEP), our Career Investment Program. Any of our CEPs are open to eligible 11th grade students who at the end of their 11th grade year earned a total of 100 credits.

The Career Investment Program is our newest program and this past school year, we offered Automotive Technology, Culinary Arts and Cosmetology. The Black Horse Pike Regional School District pays the tuition for our students to attend their chosen program. Our students are having a lot of success in these programs and expressed interest in other career programs, so have expanded to offer 10 programs that are listed on the following pages.

The Career Investment Program has an application which requires an essay and 2 letters of recommendation from teachers. This is a competitive program and once applications have been received, then a panel made up of administrators in our school district meet and review the applications, along with the student's transcript, disciplinary records and application. If they are chosen to participate in the program, then they will participate in a meeting with the Career Counselor in their building and will have to pay a \$150 non refundable deposit.

Extra-Curricular Program Update
