### **Description:**

Students will register at Camden County College for at least one college course per semester. Students are encouraged to take courses that may put them on track for a Career Certificate (see CCC brochure and the Program of Studies for the various Certificate programs), an associate's degree program or on the path to future life plans. **College Now students may choose to take a morning OR afternoon course(s) at CCC. Please let your counselor know which you are planning on, so that he/she can ensure your Highland schedule is set up correctly.**

### **College Now Program Eligibility Requirements:**

1. **Academic requirement:** Students **MUST** have  $\geq 95$  credits earned by September 1 of senior year AND a GPA  $\geq 2.0$  to participate in the CEP. Additionally, students must maintain passing grades in all courses in order to remain in the CEP program of choice.
2. **Attendance requirement:** Students **MUST** be in good standing ( $< 10$  unexcused absences) to be eligible (at the time of registration)/remain in the CEP.
3. **Conduct requirement:** Students **MUST** be in good standing ( $< 100$  conduct points) to be eligible/remain in the CEP.
4. **Removal from CEP:** School administration has the right to remove students from any CEP at any time during the school year.
5. **Graduation Requirement:** **ALL CEPs** qualify as a CTE requirement for graduation purposes.
6. **Students with free/reduced lunch can remain on campus for lunch**

### **In order to enroll at CCC:**

1. Submit a Minor Application to Camden County College.
2. Take the Accuplacer exam to determine course level placement, or submit appropriate documentation if exempt from testing.
3. Make an appointment with Mr. Don Delaney, Director of Program Outreach, to register for courses: [ddelaney@camdencc.edu](mailto:ddelaney@camdencc.edu) or 856-227-7200 ext. 4660. (Email preferred). **PARENT MUST ATTEND!**
4. Pay tuition on/before the deadline to retain enrollment in course.

**College Now Requirements/Rules:**

**Students are required to:**

1. Maintain passing grades in all required Highland coursework.
2. Submit student evaluation forms completed by the course instructor, once per semester.
3. Adhere to Highland attendance policy (lateness included) and the attendance policy of the CCC course you are enrolled in and that of the instructor.
4. **YOUR SCHEDULE WILL NOT BE CHANGED TO A HALF DAY UNTIL YOUR CONTRACT IS IN, YOU HAVE REGISTERED FOR A COURSE AND HAVE ADMINISTRATIVE APPROVAL.**

**Program Notes:**

Students must re-enroll in their respective HS **IMMEDIATELY** if a student drops/withdraws from their college course(s). **CCC courses and required materials will be paid for by the student.** CCC will discount each course by one credit hour of tuition. Tuition will vary based on the courses and required materials (ie. CD's, textbooks, uniforms, etc.).

**Credits:**

Students will earn five (5) credits for successful completion of a three (3) credit college course with a final grade of an "A", "B", "C" or "D" and the above class requirements listed under Program Information. Along with that, BHPUSD will reimburse the student in the amount of \$150 if they receive an "A", "B", or "C". **\*STUDENT WILL NOT RECEIVE CREDIT OR REIMBURSEMENT IF THEY RECEIVE AN "F" OR FAIL TO COMPLETE THE COURSE(S).\***
